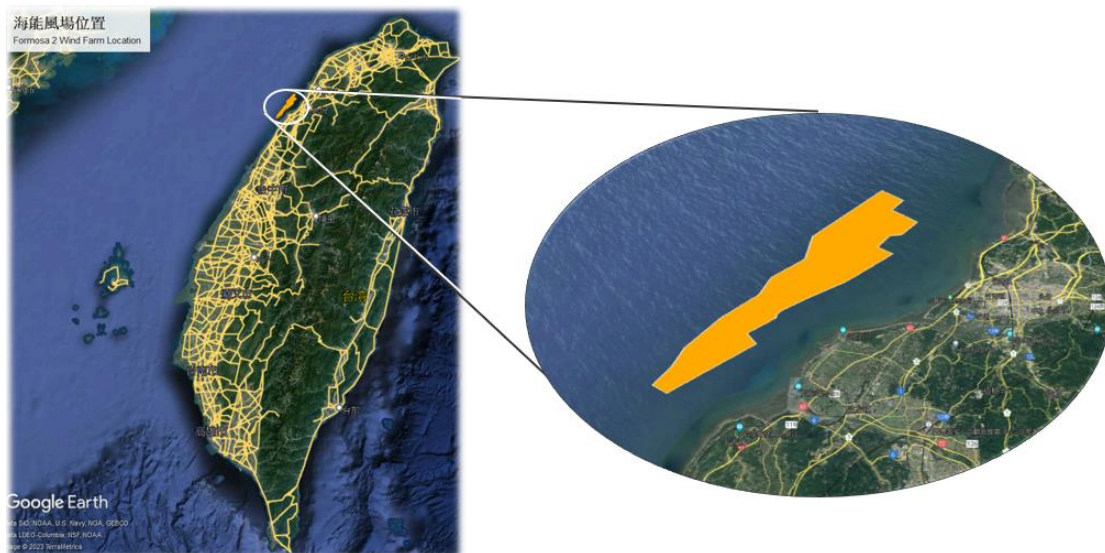

一、簡介 Introduction

海能風電為 JERA 捷熱能源(49%)、綠投資集團(26%)及風睿能源(25%)合作開發的離岸風場，總裝置容量為 376 MW，已於 112 (前)年 1 月完成 47 座風機安裝，並於 3 月完成所有風機併聯作業，每年可為 38 萬戶家庭提供潔淨電力。本年 3 月風場淨發電量約 1.39 億度。JERA, Green Investment Group, and SRE developed the offshore wind farm, Formosa 2. JERA holds a 49% stake, Green Investment Group holds 26%, and SRE holds 25%. The total installed capacity is 376 MW. In January of 2023 (last year), 47 wind turbines were installed, and in March, all turbines were successfully connected to the grid. The wind farm can provide clean electricity to approximately 380,000 households annually. In March of this year, the wind farm generated a net power output of approximately 139 million kWh.
