

一、簡介 Introduction

海能風電是離岸風電第二階段潛力場址首座完工風場,也是我國第三座完工的離岸風場。風場總裝置容量為 376 MW,已於 112 年 1 月完成 47 座風機安裝,並於 3 月完成所有風機併聯作業,每年可為 38 萬戶家庭提供潔淨電力。本年 9 月風場淨發電量約 5,545 萬度。Formosa 2 is the first completed Phase 2 offshore wind project and the third offshore wind farm in Taiwan. The total installed capacity is 376 MW. In January of 2023, 47 wind turbines were installed, and in March, all turbines were successfully connected to the grid. The wind farm can provide clean electricity to approximately 380,000 households annually. In September of this year, the wind farm generated a net power output of approximately 55 million kWh.
